NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by Richard F. Downs

There is a default by the grantor or other person owing an obligation, the performance of which is secured by

beginning February 15, 1993, together with unpaid real property taxes

In construing this notice, the singular includes the plural, the word "grantor" includes any successor in interest to the grantor as well as any other person owing an obligation, the performance of which is secured by the trust deed, and the words "trustee" and "beneficiary" include their respective successors in interest, if any.

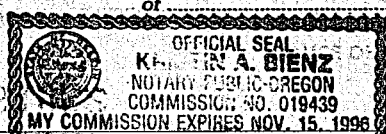
