"AGREEMENT OF UNDERSTANDING"

PacifiCorp doing business as Pacific Power & Light Company, hereinafter called "Pacific", grants permission to **GARY GRIFFITH AND KAREN L**, **GRIFFITH**, hereinafter called "Permittee", for the temporary use of that certain real property hereinafter described which constitutes Pacific's high voltage transmission line right-of-way for the purpose of maintaining certain existing improvements placed thereon by Permittee, consisting of mobile home well, and well house.

This agreement of understanding is subject to the following conditions:

- 1. The real property subject to this letter of understanding is more particularly described as Tax Lot 1600, Section 17, Township 39 South, Range 9 East, Willamette Meridian and as shown on attached Exhibit "A".
- 2. Permittee agrees to remove all such buildings and improvements from Pacific's 500 kV transmission line right-of-way within 90 days written notice from Pacific. Written notice shall be by certified mail to Permittee or his successor as shown in Klamath County Assessors Records.
- 3. Pacific's ingress, egress, and access to its existing transmission line structures will be maintained and not interrupted.
- 4. At no time shall any flammable material or any building of any kind be placed or erected within the boundaries of the existing 230 kV right-of-way, nor shall any equipment or material of any kind that exceeds 20 feet in height be placed or used by Grantor or by Grantor's heirs, successors or assigns.
