MAL 29997 MODIFICATION OF DECLARATION OF TRUST

BACKGROUND

- 1. An original Declaration of Trust for Trustees was entered on June 14, 1963 wherein George Hricziscse, Chester Truax and Marion A. Stebbins were designated Trustees;
- 2. The name of the original congregation for whom the Trustees were designated were subsequently changed from Klamath Falls, Oregon Congregation of Jehovah's Witnesses to the Ponderosa, Klamath Falls, Oregon, Congregation of Jehovah's Witnesses;
- Property was acquired in the name of the Klamath Falls,Oregon, Congregation of Jenovah's Witnesses described as follows:

Lot 3 and the South 25 feet of Lot 2, First Addition to St. Francis Park, County of Klamath, State of Oregon.

- 4. Subsequently additional property was acquired by the Congregation adjacent to the aforementioned property described as the North half of the South half of Lot 2, First Addition to St. Francis Park, in the County of Klamath, State of Oregon;
- 5. The Declaration of Trust of June 14, 1963 was subsequently modified on February 9, 1981 by the duly appointed servants of the following Congregations: Ponderosa, Klamath Falls, Oregon, Congregation of Jehovah's Witnesses; Altamont, Klamath Falls, Oregon, Congregation of Jehovah's Witnesses; Henley, Klamath Falls, Oregon, Congregation of Jehovah's Witnesses;
- 6. Subsequent to the aforementioned modification because of various territory changes, the Altamont Congregation, in whose territory the Kingdom Hall now sits, desires to assume the

7. It is now the desire of the aforementioned Congregations to memorialize prior oral agreements to effectuate the change of the trusteeship to the Altamont Congregation of Jehovah's Witnesses, and it is therefore the desire to designate and appoint Trustees from the servant body of the Altamont Congregation.

AGREEMENT

1. The Ponderosa, Klamath Falls, Oregon Congregation of Jehovah's Witnesses, formerly known as the Klamath Falls, Oregon, Congregation of Jehovah's Witnesses and the Henley, Klamath Falls, Oregon, Congregation of Jehovah's Witnesses hereby grant and convey unto the Altamont, Klamath Falls, Oregon, Congregation of Jehovah's Witnesses all its right title and interest in and to the following described property:

Lot 3 and the South 25 feet of Lot 2, First Addition to St. Francis Park.

The North half of the South half of Lot 2, First Addition to St. Francis Park, in the County of Klamath, State of Oregon.

- 2. The above-described property shall be held by the Trustees designated below for the use and benefit of the Altamont, Klamath Falls, Oregon, Congregation of Jehovah's Witnesses.
- Trustees shall henceforth be designated and appointed from the servant body of the Altamont Congregation.
- 4. Pursuant to the requirements set forth in paragraph 3 of the 1981 Modification of Declaration of Trust, the following Trustees are selected from the Altamont Congregation of Jehovah's

Witnesses: Elmer Bowman, Mark Dirr, Sec. and Gary Griffith, P.O.
