PERSONAL REPRESENTATIVE DEED

THIS INDENTURE, made this <u>68/93</u> day of June, 1993, by and between SUSANNE LEE REA, the duly appointed, qualified, and acting PERSONAL REPRESENTATIVE OF THE ESTATE OF GEORGE WILLIAM NELSON, JR., DECEASED, hereinafter called the "Grantor" (who took title as George W. Nelson), and NORMAN E. HOLLIDAY AND MARGARET E. HOLLIDAY, as tenants by the entirety, hereinafter called the "Grantee."
