This Deed of Trust shall also serve as a fi-nancing statement filed for record in the real estate records as a fixture filing pursuant to the Uniform Commercial Code.

26. Late Charge. In the event that any payment or portion thereof is not paid within fifteen (15) days commencing with the date it is due, Beneficiary may collect, and Grantor agrees to pay with such payment, a "late charge" of 4% of the monthly payment so over-will be charged. An additional 4% will be charged for each successive month the payment remains fifteen (15) days past due.
