Said property generally located in The Southeast Quarter (SE1) of The Southwest Quarter (SW1) of Section 22, Township 34 South, Range 7 East, Willamette Meridian and more specifically described as Block 5, Lot 5, Rainbow Park on The Williamson in the Official Records of Klamath County.

the location and course of said right-of-way are approximately as shown on the sketch attached as $Exhibit(e) _ A _$ and by this reference made a part hereof.

Together with the right of ingress and egress over the adjacent lands of the Grantor in order to install, maintain, repair, replace, rebuild, operate and patrol the underground electric power lines and appurtenances, and to exercise all other rights herein granted.
