UNDERGROUND RIGHT-OF-WAY EASEMENT (Individual)

A portion of The South Half (S½), of The Southwest Quarter (SW¼), of Section 1, and The East Half (E½) of Section 2, all in Township 44 North, Range 1 West, Mount Diablo Meridian.

The location and course of said easement and right-of-way are approximately as shown on the sketch attached as Exhibit(s) _____ and by this reference made a part hereof.

Together with the right of ingress and egress over the adjacent lands of the Grantor in order to install, maintain, replace, rebuild, operate and patrol the underground electric power lines and appurtenances, and to exercise other rights herein granted.
