AGREEMENT

THIS AGREEMENT is made this 2/3 day of May, 1993 by and between JOHN M. EDWARDS and DORENE RAE EDWARDS, husband and wife, hereinafter called "Edwards"; and RAYMOND C. MILLER, hereinafter called "Miller"; and KAREN A. CHRISTENSEN, formerly known as KAREN A. HAUPTMANN, hereinafter called "Christensen."

WITNESSETH:

On or about August 27, 1979 Alfred J. Hauptmann and Karen A. Hauptmann made, executed, and entered into a Land Sale Contract with John M. Edwards and Dorene Rae Edwards in which Edwards agreed to purchase from Hauptmann the property described on Exhibit A for the sum of \$30,000. Said Land Sale Contract was recorded in the Mortgage Records of Klamath County, Oregon on August 27, 1979 in Volume M 79 at Page 20326.

On or about January 31, 1984 John M. Edwards and Dorene Rae Edwards assigned all their right, title, and interest in and to the above-mentioned contract to Raymond C. Miller and Bonnie E. Miller. Said Assignment of Land Sale Contract was recorded in the mortgage records of Klamath County, Oregon on January 31, 1984 in Volume M 84 at Page 1643. Subsequently, Christensen and Miller modified the original Land Sale Contract without the participation or knowledge of Edwards.

It is the mutual desire of the parties to clear the record. NOW, THEREFORE, it is hereby mutually agreed that by virtue AGREEMENT -1-

of Edwards' assignment of their vendees' interest to Miller and the decision of Christensen and Miller to deal directly with each other without the participation or knowledge of Edwards, Miller hereby assumes all of the duties, obligations, and liabilities of Edwards as vendee as set forth in the Land Sale Contract between Christensen and Edwards, and Miller agrees to hold Edwards harmless therefrom. Christensen agrees that she has accepted the assumption by Miller and holds Edwards harmless from the vendees' obligations and responsibilities as described in the Land Sale Contract between Christensen and Edwards.


