EASEMENT

Charles C. Ehlers and Helen Meyer, tenants in common, hereinafter called Grantor, convey to Helen Meyer, hereinafter called Grantee, a perpetual and exclusive easement for a septic drain field on and under all of the real property situated in Klamath County, Oregon and described as:

A drain field easement, over, under, and across that part of land located in Lot 6, Section 12, Township 38 South, Range 8 East, W.M. Klamath County, Oregon being more particularly described as follows:

Commencing at the Center Quarter of said Section 12; thence South 00 degrees 10 minutes 37 seconds West (bearings based on Record of Survey # 2201) 653.16 feet; thence North 89 degrees 32 minutes 23 seconds West 914.77 feet to a 5/8" iron rod; thence South 17 degrees 24 minutes 31 seconds East 350.98 feet to a 5/8" iron rod; thence South 53 degrees 11 minutes 02 seconds East 190.20 feet to the true point of beginning; thence South 19 degrees 10 minutes 41 seconds East 88.64 feet; thence South 71 degrees 43 minutes 18 seconds West 57.17 feet; thence North 21 degrees 42 minutes 29 seconds West 84.40 feet; thence North 67 degrees 36 minutes 10 seconds East 60.98 feet to the point of beginning, containing 0.12 acres more or less.

Said easement is to be appurtenant to each and every portion of the real property described on Exhibit 1 attached hereto, and burdens the real property attached as Exhibit 2.

Grantee shall have the right, at all reasonable times, and in a reasonable manner, to enter upon Grantor's property for the purpose of repairing, maintaining or replacing all or any portion of the septic drain field lying within the easement.

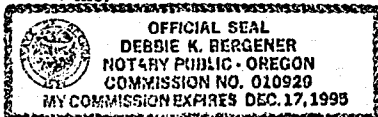

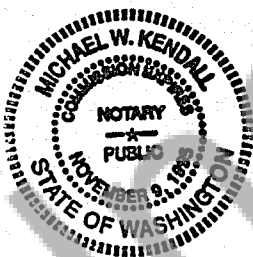
