STIPULATED DECREE

This matter, having come before Richard B. Rambo, Circuit Court Judge Protem, for a settlement hearing on May 24, 1993, and the parties being present and being represented by counsel, entered into a stipulated settlement of the claims in dispute in the above referenced case, the terms of which settlement were entered on the record before the Court and are as follows:

That a Decree of the Court shall be entered providing for 1. the specific performance of the agreement alleged in the Second Cause of Action in the Complaint filed by the Plaintiff in the above entitled matter, but amended to provide that the consideration for the conveyance of the property described below shall be \$5,000.00; and

2. That all other claims raised by the parties in the Complaint and Answer thereto be dismissed with prejudice and without costs or attorney's fees to any party. The parties each mutually 26 release one another from any claims related to the within action and the claims set forth therein. white STIPULATED DECREE

Based on the stipulation of the parties, the Court does hereby make and enter the following Decree: 2

A. Defendants Dan H. Kinsman and Cynthia L. Kinsman shall pay to the Plaintiff, in care of his attorney, Neal G. Buchanan, the 4 sum of \$5,000.00. The Plaintiff, by and through his attorney, 5 shall acknowledge receipt of said sum and file an acknowledgement 6 7 with this Court.

The contract for the sale of the following described в. property made by and between the parties shall be specifically 9 enforced. In consideration for the payment of the sum of \$5,000.00 10 by said Defendants to Plaintiff, Plaintiff shall convey to 11 Defendants Dan H. Kinsman and Cynthia L. Kinsman, husband and wife, 12 the real property located in Klamath County, Oregon described as 13 follows, to-wit: 14

15 The easterly 27.15 feet of the tract of land situated in the NW 1/4 of Section 18, Township 39 S., Range 10, E., 16 W.M., described as follows: Beginning at the Northwest corner of said Section 18, thence South 00° 01' 10" West, 2,132.47 feet; thence 17 South 89° 51' 42" East, 1765.28 feet to the true point of beginning of this description; thence North 00° 00' 22" 18 East 372.81 (372.55' by deed) feet; thence South 89° 55' 23" East 269.62 feet; thence South 00° 00' 23" West, 19 373.10 feet; thence North 89° 51' 42" West, 269.62 feet 20 to the true point of beginning with bearings based on recorded survey no. 2026 as recorded in the Klamath 21 County Surveyor's office.
