## BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, Lanny R. Garland, hereinafter called grantor, for consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Henry E. Haag, hereinafter called grantee and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A tract of land in the N 1/2 NE 1/4 of Section 8 Township 24 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at the Northeast corner of said Section 8; thence North 89 deg. 37'24" West along the North line of said Section 8, 1638.54 feet; thence South 0 deg. 00'14" East 871.96 feet to the true point of beginning; thence continuing South 0 deg. 00'14" East, 435.96 feet to the South line 985.96 feet thence North 89 deg. 44'03" West, along said South line 985.96 feet to the West line of the NE 1/4 of said Section 8; thence North 0 deg. 07'13" East, along said West line, 436.60 feet; thence South 89 deg. 41'52" East, 985.00 feet to the true point of beginning.

TOGETHER WITH AND SUBJECT TO a road and utility easement over and across the Southerly 30 feet and the Westerly 30 feet of the N 1/2 NE 1/4 of said Section 8.

FURTHER SUBJECT TO real estate taxes levied or to be levied subsequent to March 23, 1973 and liens or encumbrances created or suffered by Grantees herein or those claiming by through or under them.

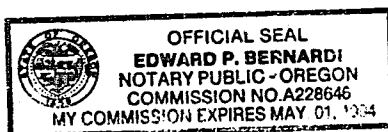

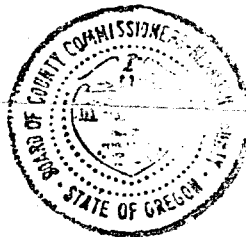
