KNOW ALL MEN BY THESE PRESENTS, Raymond G. Koellermeier, hereinafter called grantor, for consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Henry E. Haag, hereinafter called grantee and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A tract of land in the N 1/2 NE 1/4 of Section 8 Township 24 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at the Northeast corner of said Section 8; thence North 89 deg. 37'24" West along the North line of said Section 8, 655.42 feet to the East line of the W 1/2 NE 1/4 NE 1/4 of said Section 8; thence South 0 deg. 07'44" East, along said East line, 870.70 feet to the true point of beginning; thence continuing along said East line South 0 deg. 07'44" East, 435.33 feet to the South line of the N 1/2 NE 1/4 of said Section 8; thence North 89 deg 44'03" West, along said South line, 985.95 feet; thence North 0 deg 00'14" West 435.96 feet; thence South 89 deg. 41'52" East, 985.00 feet to the true point of beginning.




