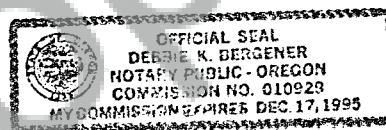

Annual installments of not less than \$701.23 due on the 18th day of January, 1992 and January, 1993 and a like payment on the 18th day of January each year after, balance of annual payment for January 18, 1992 for \$316.23 and balance of January 18, 1993 payment for \$420.73.
