6th day of July, 1993.

Thereafter, Earl Kessler, the County Engineer, filed with
 this Board a written report that contained the following:

1. A description of the ownership and uses of the property
 proposed to be vacated.
2. An assessment by the County Engineer whether the vacation
 would be in the public interest.

3. Other information required by the County Commissioners.

And after fully considering the report and other documentation
 presented

NOW AND THEREFORE:

This Board finds that the vacation of the portion of said
 Block 13; Lots 1 through 29 and the alley Block 12 and Block 12;
 Block 24; Block 11; Lots 1 through 8 in Block 11; Park Place Street:

ORDER OF VACATION -1-

Willow Street between Blocks 24 and 11; Maple Street between Park Place and Locust Street of the Plat of Ewauna Park Located in Sec. 9. T39S. R9E. W.M. Klamath County is in the public interest and finds that the Petition should be granted and that the real property be vacated.

NOW THEREFORE, IT IS HEREBY ORDERED:

That the Petition is granted and that the portion as described on Exhibit A is hereby vacated, as said vacation is in the public interest. It is further ordered that pursuant to ORS 365.366(1)(d), the vacated streets are vested in the owners of the abutting property by extension of their property boundaries to the center of the vacated streets.

IT IS FURTHER ORDERED:

That the cost resulting from the approved vacation is determined to be the sum of \$ 100.00 and that the persons liable for payment of the costs are the Petitioners.
