- B. The parties desire to, and have agreed to amend the Contract to allow construction of an additional pipeline and appurtenances within the existing right-of-way corridor described in said Contract.

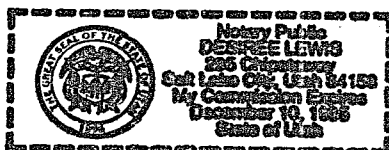

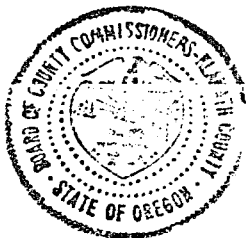
