BURIED CABLE EASEMENT

WEYERHAEUSER COMPANY a Washington corporation, hereinafter referred to as "Owner", grants to TELEPHONE UTILITIES OF EASTERN OREGON, INC., d.b.a. A strip of land six (6) feet in width, the centerline of said strip being contiguous to the centerline traverse of a buried telephone cable, situated in the SW\2SE\2 of Section 12, Township 36 South, Range 12 East, W.M.;

said centerline traverse of the aforesaid buried telephone cable being generally delineated on Exhibit "A", attached hereto and made part hereof.

Subject as to the rights of other parties with respect to any of said lands under instruments of record and existing agreements with and permits from Owner.

The terms and conditions of this Telephone Line Right-of-Way Easement are as follows:

- Owner shall have the right to use said lands for any purpose not inconsistent with the rights herein granted.
- Grantee shall have access to said telephone facilities for the purpose of exercising the rights herein granted.
- 3. All buried telephone cable is to be buried at a minimum depth of thirty (30) inches. The location of said cable is to be clearly marked by the placement of intervisible markers.

Owner shall give reasonable notice to Grantee of said operations in order that Grantee may have men and equipment available to protect or repair said equipment or facilities of Grantee.
- 5. Grantee shall pay for all damages to Owner's property resulting directly or indirectly from the negligent acts or omissions of Grantee hereunder.
- Grantee shall indemnify and hold harmless Owner from all claims for damages which may be caused by Grantee's exercise of rights herein granted.




