NOW, THEREFORE, in consideration of the sum paid for the real property, Grantor does hereby described as follows:

The S1/2NE1/4 of Section 8, Township 24 South, Range 9 East of the Willamette Meridian, lying East of the centerline of the Little Deschutes River, SAVING AND EXCEPTING the Northerly 330 feet thereof.

TOGETHER WITH an easement 20 feet in width for ingress and egress described as the centerline of said easement to be in the road as now constructed and used and approximately described as follows:
