Order:

- 1. In review of the application and attached memo addressing water, applicant will need to comply with criteria for water.
- 2. The proposed use would appear not to have an impact on the uses in the surrounding area as there are similar uses near by. Within 200 feet of subject property are two other mobile homes.
- 3. The location of the proposed use will need to meet the required setbacks in the RS Zone for an additional dwelling.
- 4. The use is allowed by CUP per section 51.530 A, additional dwelling, when lot is greater than 20,000 sq ft.
