MODIFICATION OF REAL ESTATE CONTRACT

THIS MODIFICATION OF REAL ESTATE CONTRACT ("Agreement") is between Farm Credit Bank of Spokane, successor by merger to The Federal Land Bank of Spokane ("Seller") and Redding Foundation ("Purchasers").

WHEREAS, Seller and Purchasers desire to amend that certain Real Estate Contract ("Contract") dated February 20, 1987, which was evidenced by Notice of Real Estate Contract recorded February 25, 1987, as Instrument No. 71761, Book M87, Page 3087, Real Property Records of Klamath County, Oregon.

NOW, THEREFORE, the parties agree to amend the Contract as follows:

Interest Rate Conversion. Effective October 1, 1993, the remaining amount due of \$67,092.03 shall be reamortized, with interest to be reduced to and accrue on this amount at the Farm Credit Bank Variable Base Rate ("FCB Variable Base") plus .50% per annum. The FCB Variable Base is a per annum interest rate determined from time to time by Seller in its sole discretion. The effective date of each change in the FCB Variable Base shall be determined by Seller in its sole discretion. The FCB Variable Base will increase or decrease to reflect those changes. The FCB Variable Base plus .50% is 7.10% per annum as of October 1, 1993.

The first installment shall be payable on or before the first day of November 1993, and monthly thereafter on the first day of each succeeding month with a final installment due on or before the first day of March 2007 of all remaining amounts due. The installments shall be of principal and interest in an amount sufficient to fully amortize the Contract over the term and at the interest rates provided for above. The amount of each of the above-referenced installments shall be computed by Seller consistent with the above terms.

Seller is to make any change in installment due dates that may be required by the terms of this Agreement. If the Contract is held in a third party escrow, this Agreement is conditioned upon the escrow holder's acceptance of the Agreement, related documents, and any changes in
