

DECLARATION OF LIVING TRUST

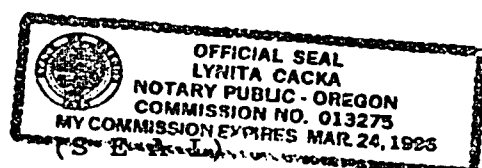
