THIS COURT FURTHER ORDERS that the Defendant pay interim maintenance to the Plaintiff for support of the Plaintiff and the child of the marriage the amount of \$4,750.00 per month commencing on the 1st day of October, 1992 and continuing on the 1st day of each and every month thereafter.


