Know All People By These Presents:

- use and benefit:
- (a) To exercise, do, or perform any act, right, power, duty, or obligation whatsoever that Ray Merman now have or may acquire the legal right, power, or capacity to exercise, do, or perform in connection with, arising out of, or relating to any person, item, thing, transaction, business property, real or personal, tangible or intangible, or matter whatsoever;

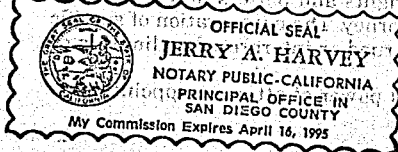
