

ASSIGNMENT OF TRUST DEED BY BENEFICIARY
OR BENEFICIARY'S SUCCESSOR IN INTEREST

hereby grants, assigns, transfers and sets over to WILLIAM S. OPPELT, TRUSTEE OF THE WILLIAM S. OPPELT REVOCABLE LIVING TRUST, dated November 18, 1993, hereinafter called assignee, and assignee's successors and assigns, all of the beneficial interest in and under said trust deed, together with the notes, moneys and obligations therein described or referred to, with the interest thereon, and all rights and benefits whatsoever accrued or to accrue under said trust deed.

The undersigned hereby covenants to and with said assignee that the undersigned is the beneficiary or beneficiary's successor in interest under said trust deed and is the owner and holder of the beneficial interest therein and has the right to sell, transfer and assign the same, and the note or other obligation secured thereby, and that there is now unpaid on the obligations secured by said trust deed the sum of not less than \$40,017.42 with interest thereon from November 12, 1993.

In construing this instrument and whenever the context hereof so requires the singular includes the plural.




EXHIBIT "A"
