SHARON ANN SIEVE and DIANE MARIE JACOBSON, as Co-Executors of
 the Will of LAURETTA A. SIEVE O'KELLEY deceased, having filed
 their Waiver of Accounting and Petition for Final Distribution,
 and the Report and Petition coming on this day regularly for
 hearing, the Court finds:

NOTICE OF HEARING of the Petition has been regularly given as
 prescribed law.

All acts and transactions of the Co-Executrixes of the Will
 of LAURETTA A. SIEVE O'KELLEY, deceased, and all allegations of
 the Petition for its settlement and for final distribution are
 true.

LAURETTA A. SIEVE O'KELLEY died testate on February 17, 1992
 in the City of Sonoma, County of Sonoma, State of California and
 was a resident thereof at the time of her death. On May 14, 1992,
 Petitioners were appointed Co-Executrixes of the decedent's Will

1 and qualified as such on said date, and since then the have been
2 and now are the Co-Executrixes of the decedent's estate.

3 Notice to Creditors has been published for the period and in
4 the manner prescribed by law. Within thirty (30) days after
5 completion of publication of Notice to Creditors an Affidavit was
6 filed with the Clerk of this Court showing due publication of
7 Notice. Letters Testamentary were issued on May 14, 1992 and more
8 than four (4) months have elapsed since the first issuance of
9 Letters. The time for filing or presenting claims has expired,
10 and the estate is now in a condition to be closed.

11 No claims have been filed or presented against the estate,
12 and all debts of the Decedent and expenses of administration have
13 been paid except closing expenses and fees.

14 No Federal Estate Tax return has been made or filed for this
15 estate because the estate is not sufficient to require such a
16 return, and no Federal or California Estate taxes are due.

17 There are no California and Federal Income taxes due and
18 payable by the estate.

19 There are no personal property taxes due and payable by the
20 estate, said tax, or deduction being passed through to the
21 beneficiaries.

22 There are no personal property taxes due and payable by this
23 estate.

24 Pursuant to the terms of the Decedent's Will, all property of
25 the estate should be distributed to the decedent's daughters
26 SHARON ANN SIEVE and DIANE MARIE JACOBSON, share and share alike:

1 All assets of the estate were the decedent's separate
2 property and are shown on the distribution schedule attached
3 hereto.

4 Petitioners herein as Co-Executrixes and as the sole
5 distributees have waived their fees and an accounting, and other
6 good cause appearing:

7 IT IS ORDERED AND ADJUDGED that:

8 1. The administration of this estate is brought to a close,
9 without the requirement of an accounting;

10 2. The Co-Executrixes of the Will of LAURETTA A. SIEVE
11 O'KELLEY, deceased have in their possession belonging to the
12 estate after deducting credits to which they is entitled, cash and
13 Promissory Notes, secured by Deeds of Trust which are more
14 particulalry described on the Exhibit A attached hereto;

15 3. All acts and transactions of the Co-Executrixes relating
16 to the matters set forth in the Waiver of Accounting, Petition and
17 Report are confirmed and approved;

18 4. The Co-Executrixes have waived their right to
19 compensation for services rendered in the administration of this
20 estate;

21 5. The Co-Executrixes are authorized and directed to pay
22 RUSSELL PARKER TAFT, their attorney, the sum of Six Thousand Eight
23 Hundred Fifty Nine Dollars and Sixty Three Cents (\$6,859.63) as
24 statutory fees for services rendered in the administration of this
25 estate;

26 6. Notice to Creditors has been given as required by law;

1 7. No California or federal taxes are due and payable by
2 this Estate;

3 8. Pursuant to the decedent's Will, the estate in
4 possession of the Co-Executrixes remaining for distribution is
5 hereby distributed to the decedent's beneficiaries as set forth on
6 Exhibit A, the distribution schedule attached hereto;

7 9. Any other property of the estate not now known or
8 discovered that may belong to the estate or in which the decedent
9 or the estate may have any interest is hereby distributed to
10 SHARON ANN SIEVE and DIANE MARIE JACOBSON, share and share alike.


