This Board finds that the vacation of the said portion Beginning at the most Easterly corner of Lot 1, Block 3 of the Plat of Doten, Klamath County, Oregon; thence Northwesterly along the Northeasterly line of Lot 1 to the most Northerly corner of Lot 1; thence Northeasterly along the Plat boundary 50.00 feet to the most Northerly corner of the Plat of Doten; thence Southeasterly along the Plat boundary 120.00 feet to a point opposite and at right angles to the point of beginning; thence Southwesterly to the point of beginning, is in the public interest and finds that the Petition should be granted and that the real property be vacated.

NOW THEREFORE, IT IS HEREBY ORDERED:
