Grantor presently assigns to Credit Union (also known as Beneficiary) all of Grantor's right, title, and interest in and to all rents, revenues, income, issues, and profits (the "Income") from the Real Property described above.

Grantor grants Credit Union a Uniform Commercial Code security interest in the Income and in all equipment, fixtures, furnishings, and other articles of personal property owned by Grantor, now or subsequently attached or affixed to the Real Property described above, together with all accessions, parts, or additions to, all replacements of and all substitutions for any of such property, and together with all proceeds (including Property are collectively referred to as the "Property."). Grantor has borrowed from Credit Union, has guaranteed to Credit Union, or otherwise has agreed to provide the Property as collateral for a debt to Credit Union in the principal amount of \$ 36,500.00 . This amount is repayable with interest in accordance with the terms of a promissory note or other credit agreement given to evidence the debt, dated 12-06-93, due not later than ten also years from the date.

The term "Indebtedness" as used in this Deed of Trust, shall mean the debt to Credit Union described above including interval these

executed unless otherwise indicated.

Indebtedness includes all loans of Beneficiary to Grantor, whether now existing or made later. This includes future loans in addition to the Note principal, up to a limit of \$ -0- However, no foan that would require providing a limit of \$-0principal, up to a limit of \$ -0-. However, no foan that would require providing a right of rescission being given to Grantor shall be secured by this Deed of Trust unless a right of rescission is in fact given to Grantor.

This Deed of Trust including the assignment of income and the security interest is given to secure payment of the Indebtedness and performance of all Grantor's obligations under this Deed of Trust and the Note and is given and accepted under the following terms:

- 1. Payment and Performance. Grantor shall pay to Cridit Union all smounts secured by this Deed of Trust as they become due, and shall strictly perform all of Grantor's obligations.
 - 2. Possession and Maintenance of the Property.
- 2.1 Possession. Until in default, Grantor may remain in possession and control of and operate and manage the Property and collect the Income from the Property.
- 2.2 Duty to Maintain. Grantor shall maintain the Property in first class condition and promptly perform all repairs and maintenance
- 2.3 Nuisance, Waste. Grantor shall neither conduct or permit any nuisance nor commit or suffer any strip or waste on or to the Property or any portion thereof including without limitation removal or alienation by Grantor of the right to remove any timber, minerals (including oil and
- 2.4 Removal of Improvements. Grantor shall not demolish or remove any improvements from the Real Property without the prior written consent of Credit Union. Credit Union shall consent if Grantor makes arrangements satisfactory to Credit Union to replace any improvement which Grantor proposes to remove with one of at least equal value. "Improvements" shall include all existing and future buildings, structures, and
- 2.5 Credit Union Right to Enter. Credit Union, its agents and representatives, may enter upon the Property at all reasonable times to attend to Credit Union's interest and to inspect the Property.

- 2.6 Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or prior to doing so and Credit Union's interest in the Property is not jeopardized. Credit Union may require Grantor to post adequate security to Credit Union's interest.
- 2.7 Duty of Protect. Grantor shall do all other acts, in addition to those set forth in this section, that from the character and use of the Property are reasonably necessary to protect and preserve the security.
- 2.8 Construction Loan. If some or all of the proceeds of the loan creating the Indebtedness are to be used to construct or complete construction of any Improvement on the Property, the Improvement shall be completed within six months from the date of this Deed of Trust and Grantor shall pay in full all costs and expenses in connection with the work.
- 3.1 Payment. Grantor shall pay when due before they become delinquent all taxes and assessments levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of any Bens having priority over or equal to the interest of Credit Union under this Deed of Trust, except for the lien of taxes and assessments not due, except for the prior indebtedness referred to in Section 17, and except as otherwise provided in Subsection 3.2.
- 3.2 Right to Contest. Granter may withhold payment of any tax, assessment, or claim in connection with a good faith dispute over the obligation to pay, so long an Credit Union's interest in the Property is not jeopardized. If a lien arises or is filed as a result of nonpayment, Granter the sum of the lien arises or, if a ben is filed, within 15 days after Granter has notice of the filing, secure the discharge of the lien or the sum of the lien arises or as a sefficient corporate surety bond or other security satisfactory to Credit Union in an amount sufficient to the han place any craim, alternary's fees, or other charges that could accrue as a result of a foreclosure or sale under the lien.

- 4.2 Applications of Preceeds. Granter shall promptly notify Credit Union of any loss or damage to the Property. Credit Union may make proof of loca if firmation fails to do so within 15 days of the crisualty. Credit Union may, at its election, apply the proceeds to the reduction of the repair or explains are the emission and repair of the Property. If Credit Union elects to apply the proceeds to retoration and repair, Granter shall such expenditure, pay or reinforumers Granter shall not be proceeded for the reasonable cost of repair or restoration if Granter is not in default hereunder. Any proceeds which have not been paid out within 180 days after their receipt and which Credit Union has not committed to the repair or expectation of the Property shall be used to prepay first accrued interest and then principal of the Indebtedness. If Credit Union holds any proceeds after payment in full of the Indebtedness, such proceeds had be paid to Granter.
- 43. Unexpired Insurance at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Beed of Frast at any frustee's or other sale held under the provision contained within, or at any foreclosure sale of such Property.
- 4.4 Compliance with Prior Indebtedness. During the period in which any prior Indebtedness described in Section 17 is in effect, compliance with the insurance provisions contained in the instrument evidencing such prior Indebtedness shall constitute compliance with the insurance provisions under this Deed of Trust, to the extent compliance with the terms of this Deed of Trust would constitute a duplication of insurance requirements. If any proceeds from the insurance become payable on loss, the provisions in this Deed of Trust for division of proceeds shall apply only to that portion of the proceeds not payable to the holder of the prior Indebtedness.
- 4.5 Association of Unit Owners. In the event the Real Property has been submitted to unit ownership pursuant to a Unit Ownership Law, or similar law for the establishment of condominiums or cooperative ownership of Real Property, the insurance may be carried by the association of unit owners in Grantor's behalf, and the proceeds of such insurance may be paid to the association of unit owners for the purpose of repairing or reconstructing the Property. If not so used by the association, such proceeds shall be paid to Credit Union.
- 4.6 Insurance Reservos. Subject to any limitations set by applicable law. Credit Union may require Borrower to maintain with Credit Union reserves for payment of insurance premiums, which reserves shall be created by monthly payments of a sum estimated by Credit Union to be sufficient to produce, at least 15 days before due, amounts at least equal to the insurance premiums to be paid. If 15 days before payment is due the reserve funds are insufficient, Borrower shall upon demand pay any deficiency to Credit Union. The reserve funds shall be held by Credit Union as a general deposit from Borrower and shall constitute a noninterest bearing debt from Credit Union to Borrower, which Credit Union may satisfy by payment of the insurance premiums required to be paid by Borrower as they become due. Credit Union does not hold the reserve funds in trust for Borrower, and Credit Union is not the agent of Borrower for payment of the insurance premiums required to be paid by Borrower.
- 5. Expenditure by Credit Union. If Grantor fails to comply with any provision of this Deed of Trust, including the obligation to maintain the Prior Indebtedness in good standing as required by Section 17, Credit Union may at its option on Grantor's behalf take the required action and any amount that it expends in so doing shall be added to the Indebtedness. Amounts so added shall be payable on demand with interest from the which Credit Union may be entitled on account of the default. Credit Union shall be in addition to any other rights or any remedies to from any remedy that it otherwise would have had.
 - 6. Warranty; Defense of Title.
- 6.1 Title. Grantor warrants that it holds merchantable title to the Property in fee simple free of all encumbrances other than those set forth in Section 17 or in any policy of title insurance issued in favor of Credit Union in connection with the Deed of Trust.
- 6.2 Defense of Title. Subject to the exceptions in the paragraph above, Grantor warrants and will forever defend the little against the lawful claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Credit Union or Trustee under this Deed of Trust, Grantor shall defend the action at Grantor's expense.
 - -7. Condemnation.
- 7.1 Application of Net Proceeds. If all or any part of the Property is condemned, Credit Union may at its election require that all or any portion of the net proceeds of the award be applied to the Indebtedness. The net proceeds of the award shall mean the award after payment of all condemnation, and attorneys' fees necessarily paid or incurred by Grantor, Credit Union, or Trustee in connection with the condemnation.
- 7.2 Proceedings. If any proceedings in condemnation are filed, Grantor shall promptly notify Credit Union in writing and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award.
 - 8. Imposition of Tax By State.
 - 8.1 State Taxes Covered. The following shall constitute state taxes to which this section applies:

 (a) A specific tax upon trust deeds or upon all or any part of the Indebtedness secured by a trust deed or security agreement.

 (b) A specific tax on a Grantor which the taxpayer is authorized to deduct from payments on the Indebtedness secured by a trust deed or security agreement.

 (c) A tax on a trust deed or security agreement chargeable against the Credit Union or the holder of the note secured. (d) A specific tax on all or any portion of the Indebtedness or on payments of principal and interest made by a Grantor.
- 8.2 Remedics. If any state tax to which this section applies is enacted subsequent to the date of this Deed of Trust, this shall have the same are met:

 - (a) Grantor may lawfully pay the tax or charge imposed by the state tax, and
 (b) Grantor pays or offers to pay the tax or charge within 30 days after notice from Credit Union that the tax law has been enacted
 - 9. Power and Obligations of Trustee.
- 9.1 Powers of Trustee. In addition to all powers of Trustee arising as a matter of law, Trustee shall have the power to take the following actions with respect to the Property upon the request of Credit Union and Grantor:

 (a) Join in preparing and filing a map or plat of the Real Property, including the dedication of streets or other rights in the public.

 (b) Join in granting any easement or creating any restriction on the Real Property.

 (c) Join in any subordination or other agreement affecting this Deed of Trust or the interest of Credit Union under this Deed of Trust 9.2 Obligations to Notify. Trustee shall not be obligated to notify any other party of a pending sale under any other trust deed or lien, or of any action or proceeding in which Grantor, Credit Union, or Trustee shall be a party, unless the action or proceeding is brought by Trustee. 10. Transfer by Grantor.
- 10.1 Consent by Credit Union. Grantor shall not transfer or agree to transfer all or part of Grantor's interest in the Property without the property without the consent of Credit Union. Any attempt to transfer shall constitute a default under this Deed of Trust. A "sale or transfer," means the

conveyance of the Real Property or any right, title, or interest therein, whether legal or equitable, whether voluntary or involuntary, by outright eale, any other method of conveyance of real property interests. If any Borrower is a corporation, transfer also includes any change in contract, or more than 25% of the voting stock of Borrower.

If Grantor or a prospective transferse applies to Credit Union for consent to a transfer. Credit Union may require such information to Concerning the prospective transferse as would normally be required from a new loan applicant. concerning the prospective transferee as would normally be required from a new loan applicant.

10.2 Condition to Consent. As a condition of its consent to any transfer, Credit Union may in its discretion impose an assumption fee in caccordance with Credit Union's fee schedule then in effect, and may increase the interest rate of the Indebtedness to the prevailing rate for similar rates then charged by Credit Union. Credit Union may increase the amount of each remaining installment so that the Indebtedness will be fully paid by the original maturity date. In no event, however, shall the interest rate be increased, nor any fee imposed, beyond the maximum rate exclusive and Credit Union, at its sole discretion, may impose as additional terms or may decline to consent to a transfer. 10.3 Effect of Consent. If Credit Union consents to one transfer, that consent shall not constitute a consent to other transfers or a waiver of this section. No transfer by Grantor shall relieve Grantor of liability for payment of the Indebtedness. Following a transfer. Credit Union may agree to any extension of time for payment or modification of the terms of this Deed of Trust or the Note or waive any right or remedy under this Deed of Trust or the Note without relieving Grantor from liability. Grantor waives notice, presentment, and protest with respect to the Indebtedness. 11.1 Security Agreement. This instrument shall constitute a security agreement to the extent any of the Property constitutes fixtures, and Credit Union shall have all of the rights of a secured party under the Uniform Commercial Code of the state in which the Real Property is located. The removal or addition of axles or wheels, or the placement upon or removal from a concrete base, shall not alter the characterization of such structures. 12. Reconveyance on Full Performance. If Grantor pays all of the Indebtedness when due and otherwise performs all the obligations improved upon Grantor under this Deed of Trust and the Note, Credit Union shall execute and deliver to Trustee a request for full reconveyance and shall execute and deliver to Grantor suitable statements of termination of any financing statement on file evidencing Credit Union's security interest in the Income and the Personal Property. Any reconveyance fee or termination fee required by law shall be paid by Grantor. 13. Default. The following shall constitute events of default:

(a) Failure of Grantor to pay any portion of the Indebtedness when it is due.

(b) Failure of Grantor to to pay any portion of the Indebtedness when it is due.

(c) Failure of Grantor within the time required by this Deed of Trust to make any payment for taxes, insurance, or for any other payment necessary to prevent filing of or to affect discharge of any lien.

(c) Dissolution or termination of existence (if Grantor is a corporation), insolvency, business failure, appointment of a receiver for any insolvency laws by or against, or the failure to obtain dismissal or deny the contents of any proceeding under any bankruptcy or insolvency laws within the time required to answer by, Grantor or any of the individuals or entities who are herein collectively referred to (d) Default of Grantor under any prior obligation or instrument securing any prior obligation, or commencement of any suit or other (e) If the Real Property has been submitted to unit ownership pursuant to a Unit Ownership Law or any similar law, failure of Grantor to perform any of the obligations imposed on Grantor by the declaration submitting the Real Property to unit ownership, by the hylaws of the association of unit owners, or by any rules or regulations thereunder. If Grantor's interest in the Real Property has been submitted to unit ownership, failure of Grantor to perform any of the obligations imposed on Grantor by the lease of the Real Property from its owner, any default under such lease which might result in termination of the lease as it of the Real Property, or any failure of Grantor as a member of an association of unit owners to take any reasonable action (f) Failure by Grantor to perform any other obligation under this Dead of Trust if:

(1) Credit Union has sent to Grantor a written notice of the failure and the failure has not been cured within 15 days of the notice, or action, or if the default cannot be cured within 15 days, Grantor has not commenced curative action or is not diligently pursuing such curative action, or (2) Grantor has given notice of a breach of the same provision(s) of this Deed of Trust within the preceding 12 months.

(g) If the interest of Grantor in the Property is a leasehold interest, any default by Grantor under the terms of the lease, or any other event (whether or not the fault of Grantor) that results in the termination of Grantor's leasehold rights; provided, that such events shall Grantor's intent to place the Personal Property and all Improvements at another location, subject to a lease of at least equal benefit to Grantor of the terminated lease, stating the location, and evidencing Grantor's right to do so.

(b) Any breach by Grantor under the terms of any other agreement between Grantor and Credit Union that is not remedied within any whether made now or later. whether made now or later.

(i) If Credit Union reasonably deems itself insecure. 14. Remedies. Upon the occurrence of any event of default and at any time thereafter, Trustee or Credit Union may declare a default and recise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

(a) Credit Union shall have the right at its option without notice to Grantor to declare the entire Indebtedness immediately due and (b) With respect to all or any part of the Real Property, the Trustee shall have the right to foreclose by notice and sale, and Credit Union shall have the right to foreclose by udicial foreclosure, in effect shall have the right to foreclose by notice and sale, and Credit Union (c) With respect to all or any part of the Personal Property, Credit Union shall have all the right to an effect in the state in which the Property is located.

(d) Credit Union shall have the right, without notice to Grantor, to take possession of the Property and collect the Income, including of this right, Credit Union may require any tenant or other user to make payments of rent or use fees directly to Credit Union. If the instruments received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants whether or not any proper grounds for the demand existed. Credit Union may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

(e) Credit Union shall have the right to have a receiver appointed to take possession of any or all of the Property, with the power to apply the proceeds, over and above covers hall established union subparagraph either in protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the Income from the Property and by law. Credit Union shall have the right to have a receiver appointed to take possession of any or all of the Property, with the power to apply the proceeds, over and above covership, against the Indebtedness. (h) Trustee and Credit Union shall have any other right or remedy provided in this Deed of Trust, or the Note. 14.2 Sale of the Property. In exercising its rights and remedies, the Trustee or Credit Union, shall be free to sell all or any part of the Property together or separately, or to sell certain portions of the Property and refrain from selling other portions. Credit Union shall be entitled to bid at any public sale on all or any portion of the Property. 14.3 Notice of Sale. Credit Union shall give Grantor reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least ten days before the time of the sale or disposition. 14.4 Waiver, Election of Remedies. A waiver by any party of a breach of a provision of this Deed of Trust shall not constitute a waiver of or prejudice the party's right otherwise to demand strict compliance with that provision or any other provision. Election by Credit Vision to parsue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or take action to perform an objection of Grantor to perform shall not affect Credit Union's right to declare a default and exercise its remedies under this Deed of Trust. 14.5 Attorneys' Fees; Expenses. If Credit Union institutes any suit or action to enforce any of the terms of this Deed of Trust, Credit Union action is involved, all reasonable expenses incurred by Credit Union that are necessary at any time in Credit Union's opinion for the protection of expenditure until repaid at the rate of the Note. Expenses covered by this paragraph include (without limitation) all attorney fees incurred for the Credit Union whether or not there is a lawsuit, the cost of searching records, obtaining title reports (including foreclasure reports), surveyore judgment collection actions. 15. Notice. - 16.2 Unit Ownership Power of Attorney. If the Real Property is submitted to unit ownership, Grantor grants an irrevocable power of attorney to Credit Union to vote in its discretion on any matter that may come before the members of the association of unit owners. Credit Union shall have the right to exercise this power, as Credit Union may shall have the right to exercise this power, as Credit Union may see fit.
- 16.3 Annual Reports. "Net operating income" shall mean all cash receipts from the Property less all cash expenditures made in connection with the operation of the Property.
- 16.4 Applicable Law. The law of the state in which the Property is located shall be applicable for the purpose of construing and determining validity of this Deed of Trust and determining the rights and remedies of Credit Union on default.
- 16.5 Joint and Several Liability. If Grantor consists of more than one person or entity, the obligations imposed upon Granter under this Deed of Trust shall be joint and several.
 - 16.6 Time of Essence. Time is of the essence of this Deed of Trust.
 - 16.7 Use.
- (a) If located in Idaho, the Property either is not more than twenty acres in area or is located within an incorporated city or village.

 (b) If located in Washington, the Property is not used principally for agricultural or farming purposes.

 (c) If located in Oregon, THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY APPROVED USES.

 (d) If located in Montana, the ≥poperty does not exceed fifteen acres and this instrument is a Trust Indenture executed in conformity with the Small Tract Financing Act of Montana.

 (e) If located in Utah this instrument is a Trust Deed executed in conformity with the Utah Trust Deed Act. UCA 57-1-19, et seq.
- 16.8 Waiver of Homestead Exemption. Borrower hereby waives the benefit of the homestead exemption as to all sums secured by this Deed of Trust.
- 16.9 Merger. There shall be no merger of the interest or estate created by this Deed of Trust with any other interest or estate in the Property at any time held by or for the benefit of Credit Union in any capacity, without the written consent of Credit Union.
- 16.10 Substitute Trustee. Credit Union, at Credit Union's option, may from time to time appoint a successor trustee to any Trustee appointed hereunder by an instrument executed and acknowledged by Credit Union and recorded in the office of the Recorder of the county where the Property is located. The instrument shall contain the name of the original Credit Union, Trustee, and Borrower, the book and page where this Deed of Trust is recorded, and the name and address of the successor trustee. The successor trustee shall, without conveyance of the Property, succeed to all the title, powers, and duties conferred upon the Trustee herein and by applicable law. This procedure for substitution of trustee shall govern to the exclusion of all other provisions for substitution.
- 16.11 Statement of Obligation. If the Property is in California, Credit Union may collect a fee not to exceed \$50 for furnishing the statement of obligation as provided in Section 1943 of the Civil Code of California.
