KNOW ALL MEN BY THESE PRESENTS, That FN Realty Services, Inc., a California corporation as Trustee under Trust 7213

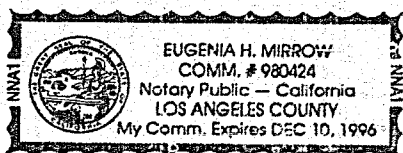
