## SPECIAL WARRANTY DEED

**KNOW ALL MEN BY THESE PRESENTS,** That Leonard W. Miles and Bernice M. Miles, husband and wife, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Doyce W. Stone and Winifred O. Stone, husband and wife, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Beginning at the 5/8 inch iron pin and aluminum cap marking the east one-quarter corner of Section 18, Township 24 South, Range 7 East of the Willamette Meridian and the Initial Point of the plat of Tract No. 1052 Crescent Pines, recorded in Klamath County, Oregon Plat records; thence N $74^{\circ}59'35''$  W, 274.32 feet along the north line of said plat to an iron pin marking the Northwest corner of Lot 1, Block 4 thereof; thence N $52^{\circ}43'28''$  W, 60.00 feet continuing along the North line of said plat, being the Northerly right of way line of Pine Creek Loop, to a point; thence N $56^{\circ}53'13''$  E, 493.63 feet to a point on the Southerly right of way line of the Willamette Highway 58; thence, S $52^{\circ}43'28''$  E, 620.00 feet, more or less, along the Southerly right of way line of said highway to its intersection with the South Line of the SW $\frac{1}{4}$ , SW $\frac{1}{4}$ , NW $\frac{1}{4}$  of Section 17, Township 24 South, Range 7 East of the Willamette Meridian; thence, Westerly along the South line of said SW $\frac{1}{4}$ , SW $\frac{1}{4}$ , NW $\frac{1}{4}$  of Section 17 the point of beginning in Klamath County, Oregon.

And the grantor hereby covenants to and with the grantees and grantees' heirs, successors and assigns that the real property is free from encumbrances created or suffered thereon by grantor and that grantor will warrant and defend the same and every part and parcel thereof against the lawful claims and demands of all persons claiming by, through, or under the grantor.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$13,500.00
