DESCRIPTION OF PROPERTY

The following described real property situate in Klamath County, Oregon:

The Wi of the NWi of Section 16, Township 39 South, Range 10 East of the Willametre Meridian, SAVING AND EXCEPTING therefrom that portion of the SWi of the MWi lying Southerly of the O.C.& E. Railroad, and SAVING AND EXCEPTING therefrom that portion of the NWi lying Northerly of the Klamath Falls.

The SE†NW‡ and all that portion of the NE‡NW‡ lying Southerly of the Klamath Falls-Lakeview Highway, and all that portion of the NE‡SW‡ lying Northerly of the O.C.& E. Railroad, all in Section 16, Township 39 South, Range 10 East of the Willamette Meridian.

ALSO beginning at the Northeast corner of the WisWi of Section 16; thence Southerly to the Northerly line of the right of way of the Oregon, California & Eastern Railway (sometimes referred to as Klamath Falls Municipal Railway); thence Northwesterly along said right of way to the intersection with the South the said WisWi of said Section 16; thence Easterly along the North line of the said WisWi to the place of beginning, and being that portion of the said NWiSWi lying Northerly of said Railway right of way.

ALSO a piece or parcel of land in the SW\(\frac{1}{2}\)SW\(\frac{1}{2}\) of Section 9, Township 39 South, Range 10 East of the Willamette Meridian, more fully described as follows: Beginning at the section corner common to Sections 8, 9, 16 and 17 of the said Township and Range; and running thence N. 0°40' E. along the section line between the said Sections 8 and 9, 240 feet, more or less, to the Suthwesterly boundary of the right of way of the present Klamath Falls-Lakeview to its intersection with the section line between the said Sections 9 and 16; thence N. 89°33' W., along the last mentioned section line 357 feet, more or less, to the said point of beginning.
