KNOW ALL MEN BY THESE PRESENTS, That DALE W. JONGEWAARD, TRUSTEE, UNDER THE JONGEWAARD LOVING TRUST DATED APRIL 29, 1992, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto DALE W. JONGEWAARD hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of KLAMATH, State of Oregon, described as follows, to-wit:

A parcel of land located in the E $\frac{1}{2}$ of the SW $\frac{1}{4}$ of Section 22, Township 38 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point of the East line of the SW $\frac{1}{4}$ of said Section 22 from which point the center one-quarter ^{corner} of said Section 22 bears North 0°46'35" East 100.00 feet; thence along said East line of the SW $\frac{1}{4}$ South 00°46'35" West 1439.57 feet to a point on the Northeastly right of way line of the Collman Dairy Road; thence along said right of way line North 33°16'08" West 533.20 feet; thence North 36°13'39" West 222.68 feet; thence 159.28 feet along the arc of a 680.0 foot radius curve to the left; the long chord of which bears North 42°56'15" West 158.91 feet; thence North 49°38'51" West 99.66 feet; thence, leaving said right of way line North 44°45'29" East 891.62 feet to the point of beginning.

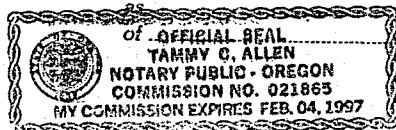
