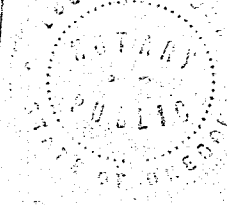


KNOW ALL MEN BY THESE PRESENTS, That Jo ANN C. LOW
