CONDITIONAL ASSIGNMENT OF RENTALS

THIS AGREEMENT, Entered into this 10th day of March , 1994 , between Warren S. Wiley and Sharon J. Wiley

hereinafter referred to as Owner, and KLAMATH FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, A Federal Corporation, hereinafter referred to as Mortgagee.

## WITNESSETH:

WHEREAS, Owner is the present owner in fee simple of property described as: Lots 9, 10, 11 and 12, Block 19, SECOND ADDITION TO THE CITY OF KLAMATH FALLS, in Code 1 Map 3809-29AB TL 4800 Key#186293

in Klamath County, State of Oregon, and the mortgagee is owner and holder of a first mortgage covering said premises, which said mortgage is in the original principal sum of \$ 69,000.00 made by owner to mortgagee under the date of March 10, 1994 ; and

WHEREAS, Mortgagee, as a condition to making said loan and accepting said mortgage has required the execution of this assignment of the rentals of the mortgage premises by owner.

NOW, THEREFORE, in order further to secure the payment of the indebtedness of the owner to mortgagee and in consideration of the accepting of the aforesaid mortgage and the note to mortgagee and in consideration of the accepting of the aforesaid mortgage and the note secured thereby, and in further consideration of the sum of One Dollar paid by mortgagee to owner, receipt of which is hereby acknowledged, the said owner does hereby sell, assign, mortgaged premises, this assignment to become operative upon any default being made by the to remain in full force and effect so long as any default continues to exist in the matter of the making of any of the navments or the performance of any of the covenants set forth in the the making of any of the payments or the performance of any of the covenants set forth in the aforesaid mortgage or the notes secured thereby.

- 1. In furtherance of the foregoing assignment, the owner hereby authorizes the mortgagee, its employees or agents, at its option, after the occurance of a default as aforesaid to enter upon the mortgaged premises and to collect, in the name of the owner, or in thier own name as the rents accrued but unpaid and in arrears at the date of such default, as well as the rents thereafter accrued but unpaid and in arrears at the date of such default, as well as the rents thereafter accruing and becoming payable during the period of the continuance of the said or any other default; and to this end, the owners further agree they will facilitate in execute a written notice to the tenant directing the tenant to pay rent to the said mortgagee.
- 2. The owner also hereby authorizes the mortgagee upon such entry, at its option, to take over and assume the management, operation and maintenance of the said mortgaged premises and to perform all acts necessary and proper and to expend such sums out of the income of the mortgaged premises as may be needful in connection therewith, in the same manner and to the same extent as the owner theretofore might do, including the right to effect new leases, to cancel or surrender existing leases, to alter or amend the terms of existing leases, to make concessions to tenants, the owner hereby releasing all claims against mortgagee arising out of account as hereinafter set forth.

- The mortgagee shall, after payment of all proper charges and expenses, including reasonable compensation to such Managing Agent as it shall select and employ and after the accumulation of a reserve to meet taxes, assessments, water rents and fire and liability insurance in requisite amounts, credit the net amount of income received by it from the mortgaged premises by virture of this assignment, to any amounts due and owing to it by the owners under the terms of the mortgage and the note secured thereby but the manner of the application of such net income and what items shall be credited, shall be determined in the sole discretion of the mortgagee. The mortgagee shall not be accountable for more moneys than it actually received from the mortgaged premises; nor shall it be liable for failure to collect rents. The mortgagee shall make reasonable effort to collect rents, reserving, however, within its own discretion, the right to determine the method of collection and the extent to which enforcement of collection of delinquent rents shall be prosecuted.
- 4. In the event, however, that the owner shall reinstate the mortgage loan completely in good standing, having complied with all the terms, covenants and conditions of the said mortgage and the note secured thereby, then the mortgagee within one month after demand in writing shall re-deliver possession of the mortgaged premises to owner, who shall remain in continn again take possession of the mortgaged premises under authority of this instrument. option, again take possession of the mortgaged premises under authority of this instrument.
- 5. The owner hereby covenants and warrants to the mortgagee that neither it, nor any premises, nor any prior assignment or pledge of the rentals of the mortgaged whole or any part of the mortgaged premises. The owner also hereby covenants and agrees not whole or any part of the mortgaged premises. The owner also hereby covenants and agrees not to collect the rents of the said mortgaged premises in advance, other than as required to be paid in advance by the terms of any rental agreement, and further agrees not to do any other which would destroy on impain the benefits to the montgages of this assignment act which would destroy or impair the benefits to the mortgagee of this assignment.
- 6. It is not the intention of the parties hereto that an entry by the mortgagee upon the mortgagee premises under the terms of the instrument shall constitute the said mortgagee a "mortgagee in possession" in contemplation of law, except at the option of the mortgagee.
- 7. This assignment shall remain in full force and effect as long as the mortgage debt to the mortgagee remains unpaid in whole or in part.
- 8. The provisions of this instrument shall be binding upon the owner, its successors or assigns, and upon the mortgagee and its successors or assigns. The word "Owner" shall be equity of redemption to or in the aforesaid mortgaged premises.
