## RELEASE OF OPTION

## RECITALS

WHEREAS, a document entitled "Standard Option Contract" was entered into on the 1st day of July, 1991, by and between ABLE PROPERTY SERVICES, INC., an Oregon Corporation (hereinafter referred to as "Able"), (hereinafter referred to as the "Option"), and RENEE' E. 2. That any rights or obligations that arise as the result of the execution of the above-mentioned Standard Option Contract will forever be null and void; and

3. That Able Property Services, Inc., does hereby remise, release and quitclaim unto Renee' Maddox Chapman, her heirs, successors and assigns, all of Able's right, title and interest in and to that certain real property described hereinabove, together with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining.
