

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated November 15, 1988, executed and delivered by ROBERT A. KENT and SALLY M. 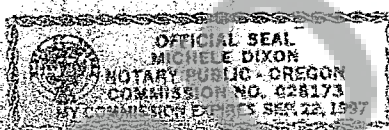
