KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated April 9, 1977, executed and delivered by Randy Raughter as grantor and recorded on April 21, 1977 in the Mortgage Records of Klamath County, Oregon, in Book/Tract/Volume No. M92 at page 8510, and for as fee/file/instrument/microfilm/reception No. (indicate which), conveying real property situated in that county described as follows:


