

## Description of the property

The following described property situated in the NE 1/4 of Section 19, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at a point which is North a distance of 255.5 feet and West a distance of 1337.7 feet from the true line which marks the Southeast corner of Section 19, Township 38 South, Range 9 East of the Willamette Meridian, ssid point of beginning also being on the Southerly right of way of Front Street (now known as Hank's Street) which point is 30.0 feet East of the Northeast corner of Block 2, Klamath Lake Addition, as shown on the official plan of said Klamath Lake Addition on file in the County Clerk's office in Klamath County, Oregon; and running South along the 1/16 line on the West side of the NW 1/4 of the SE 1/4 of said Section 19, a distance of 220.0 feet to the true point of beginning, thence North 70°53' East a distance of 232.5 feet; thence North 36°12' East to the South right of way line of Lakesport Blvd., thence Southeasterly along said right of way line to the Northwest corner of that property conveyed to Ralph Smith and Alice Smith husband and wife and William Smith and Wendell Smith, and described as Parcel 2 in Deed Volume 215 at page 170, Deed Records of Klamath County, Oregon, thence Southerly along the Westerly line of said Deed Volume 215 page 170, Deed Records of Klamath County, Oregon to the Southwest corner thereof, thence West to the Southeast corner of that certain property described in Deed Volume 285 on page 444, Deed Records of Klamath County, Oregon, said point being West 210 feet from the West line of the NE 1/4 of said Section 19, thence North 260 feet to the Northeast corner of that certain property described in Deed Volume 295 page 177, Deed Records of Klamath County, Oregon, thence West along the North line of said Deed Volume 210 feet to the West line of the NE 1/4 of said Section 19, thence North along said West line to the point of beginning.
