WARRANTY DEED

Beginning at a Brass Cap at the NE corner of the SW 1/4 SE 1/4 of Sec 23, TWP 33 South, Range 18 EWM, thence S 0 deg 03' W 243.0 ft, S 75 deg 54' W 295.50 ft; N 65 deg 17' 30" W 222.80 ft; N 27 deg 54' E 89.20 ft; N 15 deg 10' E 105.00 ft; N 19 deg 24' E 95.31 ft to the edge of the River Bank, N 39 deg 50' 52" E 75.50 ft along the edge of the river bank to the point of intersection with the North boundary of the SW 1/4 SE 1/4, thence S 89 deg 58' 15" E along the North boundary of the SW 1/4 SE 1/4 347.00 ft to the point of the beginning.
