IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. That Tanya D. King, as Conservator for the minor
 children James King and Dawn King, may purchase the residence located
 at Highway 97, Crescent, Oregon for the sum of \$52,000 as
 Conservator for James King and Dawn King and their interests
 herein shall be shown on the closing documents as James King
 owning seventy percent (70%) and Dawn King owning thirty percent
 (30%).

2. Rent shall be paid to James and Dawn King in the sum of
 no less than \$264.98 per month and from said sum the payments on
 the underlying obligation, taxes and insurance shall be paid.

3. Payments shall be made through Kenco Data Collection
