DO hereby constitute and appoint and my true and lawful attorney for me and in my name, place and stead, and for my use and benefit so named, are for, recover, collect, and receive all such sums of money, debts, rents, dues, accounts, balances, interests, dividends, annuities and demands whatsoever, as are now or shall hereafter become due, owing, payable or belonging to me, to have, use and take all lawful ways and means in my name or otherwise for the recovery thereof, and to compromise, settle and adjust and to execute and deliver acquittances or other sufficient discharge for any of the same; to bargain, contract for, purchase, receive and take lands, tenements, hereditaments, and except the same and possession thereof and all deeds and other instruments in the law therefor, and to lease, let, demise, bargain, sell, renounce, release, convey, mortgage and hypothecate lands, tenements and hereditaments, including my right of ownership in any of the same for such price, upon such terms and conditions and with such covenants as my attorney shall think fit; to sell, transfer and deliver all or any shares of stock owned by me in any corporation for any price and receive payment therefor and to vote any such stock as my proxy; to bargain for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with goods, wares and merchandise, choses in action, and other property in possession or in action, and to make, do and transact all and every kind of business of whatsoever nature or kind; for me and in my name and as my act and deed, to sign, seal, execute, acknowledge and deliver all deeds, covenants, indentures, agreements, trust agreements, mortgages, pledges, hypothecations, bills of lading, bills, bonds, notes, evidences of debt, receipts, releases and satisfactions of mortgages, judgments and other debts payable to me and other instruments in writing of whatever kind and nature which my attorney in his/her absolute discretion shall deem to be my best interests; to have access to any safety deposit box which has been rented in my name or in the name of myself and any other person or persons, to sign, discount, enclose, deliver and/or deposit all checks, drafts, notes and negotiable instruments payable to my order, to withdraw money deposited in my name with any bank, by check or otherwise, and to do all the business which may be necessary to be done in connection therewith, and deliver any tax return or form and pay taxes, and to do all other acts and things which may be necessary.

GIVING AND GRANTING unto my attorney full power and authority to do and perform all and every act and thing whatsoever regular and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do it personally present, with full power of substitution and revocation, herein ratifying and confirming all that my attorney or my attorney's substitute or substitutes shall lawfully do or cause to be done by virtue of this present.

This power shall take effect: (delete inapplicable phrase)

(a) on the date next written below;

(b) on the date I may be adjudged incompetent by a court of proper jurisdiction.

If neither phrase (a) nor (b) is deleted, this power shall take effect on the date next written below.  
My attorney and all persons unto whom these presents shall come may assume that this power of attorney has not been revoked until given actual notice either of such revocation or of my death.

In continuing this instrument, and unless the context so requires, the singular includes the plural.
