

MITTED POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, TERRY L. DRAZIL, have made, constituted and appointed MARIE E. DRAZIL, whose address is 30200 Democrat Rd., Malin, OR 97632, my true and lawful attorney with power to act in my stead and in my behalf to make, do, and transact all of the following business whatsoever in my name as fully as though I myself were acting; said power to include full power and authority to do or perform for me, in my name, place and stead, the following to wit:

To sell, transfer, convey, exchange, deed, mortgage, or otherwise dispose of any or all of my interest in the below described real estate: Beginning on the Easterly line of Lincoln (formerly Washington) Street 40 feet Southerly from the Northerly corner of Lot 1 of said Block and Addition; thence Easterly at right angles to Lincoln Street 34 1/2 feet; thence Southerly and parallel with Lincoln Street 40 feet to the Southerly line of said Lot 1; thence Westerly along the Southerly line of said Lot 1, 84 1/2 feet to the Easterly line of Lincoln Street; thence Northerly along the Easterly line of Lincoln Street, 40 feet to the place of beginning. My attorney may do this at either public or private sale, upon such terms, consideration and conditions as my said attorney shall deem acceptable, and to execute and deliver such instruments and writings as are necessary and/or appropriate for such conveyance under the circumstances.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, and thing whatsoever that is necessary in the execution of this power of attorney, fully as I might or could do if present and acting.

I hereby ratify and confirm whatsoever my attorney shall do in the premises by virtue of this authority.

This power shall remain in full force and effect until April 9, 1994.
