

WARRANTY DEED

Lot 24, Block 53, KLAMATH FALLS FOREST ESTATES, HIGHWAY 63 UNIT, PLAT NO. 2, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

To Have and to Hold the same unto the grantee and grantee's heirs, successors and assigns forever.
