DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under those certain trust deeds dated September 7, 1988; and June 20, 1989, executed and delivered by DENNIS J. ENGLEHARD, husband & wife, husband & wife, as grantor(s) and recorded on September 9, 1988; and June 26, 1989, in the Mortgage Records of Klamath County, Oregon, in book M88; and M89, at pages 14765; and 11321, conveying real property situated in said county described in above mentioned trust deeds, having received from the beneficiary under said trust deeds written requests to reconvey, reciting that the obligations secured by said trust deeds have been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deeds.

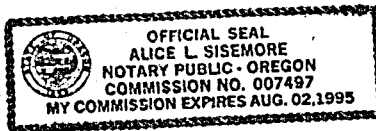
