MEMORANDUM OF MEMBERSHIP AGREEMENT

WHEREAS, RICH McINTYRE and KAREN GREENE, husband and wife, hereinafter "Grantor", of Fort Klamath, Oregon, doing business as THE WILLIAMSON RIVER CLUB, hereinafter "WRC", have executed a membership agreement with RICHARD OSBORNE, hereinafter "Grantee", of P. O. Box 221368, Carmel, California, 93922, with an effective date of October 27, 1993;

WHEREAS, said membership agreement provides that the Twenty Thousand Dollar (\$20,000) investment in the WRC shall be secured by a third deed of trust, hereinafter "Membership Trust Deed", on the real property on which the WRC is located in Klamath County, Oregon, described as follows, to-wit:

PARCEL 1: The East one-half of the Southwest quarter, the Northwest one quarter of the Southeast quarter of Section 26, Township 34 South, Range 6 East of the Willamette Meridian, Klamath County, Oregon.

PARCEL 2: The Northeast quarter of the Northeast quarter of the Northwest quarter; North one-half of the Southeast quarter of the Northeast quarter of the Northwest quarter of Section 35, Township 34 South, Range 6 East of the Willamette Meridian, Klamath County, Oregon.

ALSO THE FOLLOWING DESCRIBED TRACT OF LAND: Beginning at the Northwest corner of the Northeast quarter of Section 35, Township 34 South, Range 6 East of the Willamette Meridian; thence South 15 chains; thence East 3 and 1/3 chains; thence North 15 chains; thence West 3 and 1/3 chains to the point of beginning.

EXCEPTING THEREFROM THE FOLLOWING: Beginning at a point on the section line between Section 26 and Section 35, Township 34 South, Range 6 East of the Willamette Meridian, 675.7 feet West of the Quarter Section corner; thence South along the West line of the Northeast quarter of the Northwest quarter of Section 35 and of the North one-half of the Southeast quarter of the Northeast quarter of the Northwest quarter of Section 35 a distance of 990 feet; thence East on the South line of the North one-half of the Southeast quarter of the Northwest quarter of Section 35, a distance of 530 feet; thence North a distance of 330 feet; thence West a distance of 135 feet; thence North a distance of 660 feet to intersect the above mentioned section line 395 feet East of point of beginning; thence West along the section line 395 feet to point of beginning.

WHEREAS, Paragraph 11.7 of the Membership Trust Deed specifically provides that Grantor may obtain future advances from additional members, who shall become additional beneficiaries under the Membership Trust Deed and have the same priority as the Original Beneficiaries as and from the date of recording of the same provided that a Memorandum of the Membership Agreement is recorded specifically referring to the recording number of the Membership Trust Deed and the date of recording;
