

WARRANTY DEED Kepner, Kepner and Sario, aka

KNOW ALL MEN BY THESE PRESENTS, That Fred H. Kepner, Lucile F. Kepner
and Barbara K. Sario, hereinlater called the grantor, for the consideration hereinafter stated, to grantor paid by David B. Stock
the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and
assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or now
pertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Beginning at a point which lies North 1° 12' West a distance of 331.4
feet along the section line, and North 88° 57' East a distance of 331.4
feet along the section line, and North 88° 57' East a distance of 331.4
feet parallel to the Meridian, and running thence; continuing North 88° 57' East a distance of 67.5 feet to a point; then
on the North line of the S 1/2 SW 1/4 NW 1/4 of Section 11, thence
South 88° 58' West along the North line of the S 1/2 SW 1/4 NW 1/4
of Section 11, a distance of 67.5 feet to an iron pin; thence South 12' East a distance of 331.4 feet more or less to the Point of
Beginning, being in the S 1/2 SW 1/4 NW 1/4 of Section 11, Township
39 South Range 9 East of the Willamette Meridian,
(for continuation of this portion lying within Winter Avenue.
In space insufficient, continue description on reverse side of this deed)

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.
And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that
grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as
noted of record as of the date of this deed, and those apparent upon the
land, if any, as of the date of this deed,

and that
and demands of all persons whomsoever, except those claiming under the above described encumbrances.
