KNOW ALL MEN BY THESE PRESENTS, That LARRY PASCHKE

hereinafter called the Grantor, for the consideration hereinafter stated, to Grantor paid by WILLIAM W. WALKER and JAN MARIE WALKER, husband and wife, hereinafter called the Grantee, does hereby grant, bargain, sell and convey unto the said Grantee and Grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: any right, title and interest I may have in the following described property:

All that portion of the SE1/4SW1/4 of Section 6, Township 41 South, Range 11 East of the Willamette Meridian, Klamath County, Oregon lying Northerly of the U.S.R.S. Drain No. 8 and lying Southerly of the Great Northern Railway Boundary. EXCEPTING THEREFROM the Easterly 33 feet thereof, reserved in Deed recorded in Volume M68, page 29, Microfilm records of Klamath County, Oregon.

SUBJECT TO: Easements, restrictions and rights-of-way of record or apparent on the land.

This conveyance carries with it no easement or other right to carry irrigation water across any property owned by the Grantor for the benefit of this parcel.

To Have and to Hold the same unto the said Grantee and Grantee's heirs, successors and assigns forever. And said Grantor hereby covenants to and with said Grantee and Grantee's heirs, successors and assigns, that Grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

except those above stated, and that Grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
