- Any breach of Grantor under the terms of any other agreement between Grantor and Lender that is not remedied within any grace period provided therein, including without limitation any agreement concerning any indebtedness of Grantor to Lender, whether made now or later.

18. RIGHTS AND REMEDIES ON DEFAULT.

- Upon the occurrence of any event of default and at any time thereafter, Trustee or Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies proved by law:
 - (1) Lender shall have the right at its option without notice to Grantor to declare the entire Indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.
 - With respect to all or any part of the Real Property, the Trustee shall have the right to foreclose by notice and sale, and Lender shall have the right to foreclose by judicial foreclosure, in either case in accordance with and to the full extent provided by applicable law.

- c. Notice of Sale. - d. Waiver, Election of Remedies. If the Rents are collected by Lender, then Grantor irrevocably designates Lender as Grantor's attorney in fact to endorse instruments received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. - d. Appoint Receiver. 21. ATTORNEY FEES; EXPENSES.

Whether or not any court action is involved, all reasonable expenses incurred by Lender which in Lender's option are necessary payable on demand and shall bear interest or the enforcement of its rights shall become a part of the Indebtedness until repaid. Expenses covered by this paragraph include, without limitation however subject to any limits under applicable law, Lender's attorney fees whether or not there is a lawsuit, including attorney fees for bankruptcy proceedings (including efforts to modify or vacate any automatic stay or injunction), appeals and any anticipated post-judgment collection services, insurance, and fees for the Trustee, to the extent permitted by applicable law. 22. RIGHTS OF TRUSTEE.

Trustee shall have all of the rights and duties of Lender as set forth in this section.

- a. Power of Trustee. Any party may change its address for notices under this Trust Deed by giving formal written notice to the other parties, specifying that the purpose of the notice is to change the party's address.
