KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated January 31, 19 79, executed and delivered by Robert L. Carson and Dixie A. 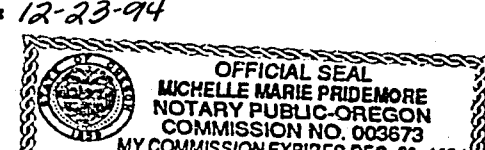
