This Power of Attorney shall not be affected by disability of the myself and shall otherwise continue in full force and effect until revoked.

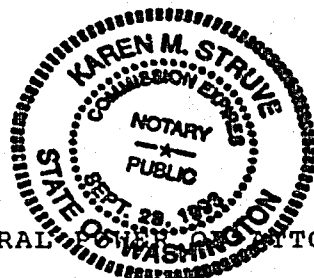
