KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated June 19, 1990, executed and delivered by Richard A. DeChellis and Pamela R. 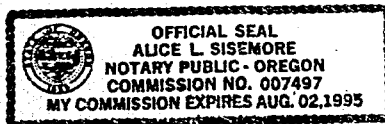
