DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under those certain trust deeds dated August 16, 1963; April 30, 1984; July 7, 1989, executed and delivered by JOHN E. 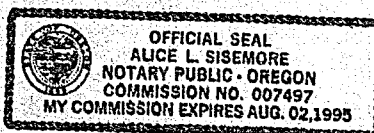
